
**A BY-LAW TO AMEND THE
TOWN OF RIVERVIEW ZONING BY-LAW**

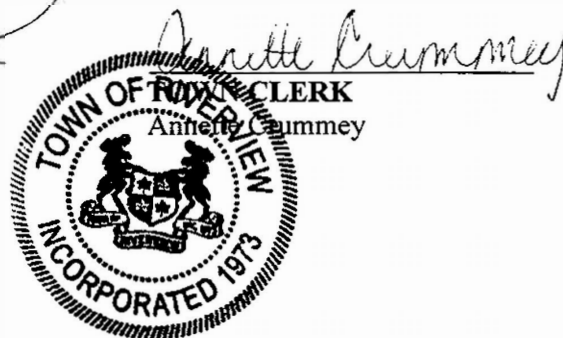
BE IT ENACTED by the Town Council of the Town of Riverview as follows:


