The purpose of the proposed amendments (By-laws 300-33-6 and 300-7-14) is to redesignate the properties on Hillsborough Road bearing PIDs 05009949 and 00642736 from CU – Community Use to C - Commercial, and to rezone said properties from OS – Open Space to SC – Suburban Commercial in order to permit a drive-thru restaurant, service station, and future commercial development;




1. Schedule A, being the Generalized Future Land Use Map, is hereby amended as shown on the map dated February 14, 2024, attached hereto as Schedule A-6.


